## **Seat Notes - Motor Vehicle Declaration for Non-SACU**

## **Purpose of the Seat Notes**

The purpose of this document is to assist declarants on the capturing of declarations for the importation of motor vehicles from Non-SACU countries, following the imposition of a motor vehicle levy on the importation of used motor vehicles;

- 3 (1) A levy of 3% on Free on Board value shall be imposed on every motor vehicle that is six (6) to ten (10) years old
- (2) A levy of 6% on Free on Board value shall be imposed on every motor vehicle that is eleven (11) to fifteen (15) years old

## **Special notation:**

APC 000 Common Regime applies to New and Used Motor Vehicles up to 5 years


APC 998 applies to imported used motor vehicles of ages from 6 years to 10 years

APC 997 applies to imported used motor vehicles of ages from 11 years to 15 years


The screen shot below shows a declaration whereby a motor vehicle was declared using APC 000.


A message will pop up reminding declarants to ensure that they have captured the correct APC with the correct supporting documents.

NB: amongst others, the motor vehicle import permit is a required supporting document




Where APCs 997 and 998 are used the declaration will request an attachment of the import permit from Ministry of Finance (Scan Doc Code IMMF).







Taxes collected under APC 997 are displayed below with the imposition of the New Motor Vehicle levy (11 - 15 years)




Taxes collected under APC 998 are displayed below with the imposition of the New Motor Vehicle levy. (6 - 10 years)
